**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF LEVY COUNTY, FLORIDA, PROVIDING FOR AMENDMENT OF THE SCHEDULE OF PERMIT FEES AND SERVICE CHARGES FOR PERMITS, REVIEWS, AND SERVICES PROVIDED BY THE LEVY COUNTY DEVELOPMENT DEPARTMENT AND THE LEVY COUNTY ROAD DEPARTMENT; PROVIDING FOR REPEAL OF CONFLICTING FEE SCHEDULES; PROVIDING AN EFFECTIVE DATE.**

RECITALS

**WHEREAS**, on September 3, 2013, the Board of County Commissioners of Levy County, Florida ("the Board") adopted Resolution 2013-38 establishing a schedule of permit and service fees charged by the Levy County Development Department ("the Development Department") and the Levy County Road Department ("the Road Department") for various services and applications; and

**WHEREAS**, the Board now desires to amend some of the fees set forth in Resolution 2013-38; and

**WHEREAS**, the Board finds it is in the best interests of the County and its citizens to amend the fees set forth in Resolution 2013-38 as set forth herein;

**NOW THEREFORE, BE IT RESOLVED** by the Board of County Commissioners, of Levy County, Florida that:

1. Sections B.13.(a), B.13.(b), and B.13.(c), of the Levy County Development Department or Road Department Schedule of Permit and Service Fees, attached as Exhibit "A" to Resolution 2013-38 (such Schedule of Permit and Service Fees herein

“the Schedule”), are hereby amended as follows (additions shown as underlined; deletions shown as ~~stricken through~~):

**B. DEVELOPMENT PERMITS - PLANNING AND ZONING FEES**

...

13. ZONING COMPLIANCE REVIEW (for permitted or accessory uses):
- a) Single-Family Residential . . . . . ~~\$25.00~~100.00
  - b) Additions to Single-Family Residence . . . . . ~~\$25.00~~100.00
  - c) Residential Accessory Building . . . . . ~~\$15.00~~25.00

The remainder of the Schedule not specifically amended by this Section 1 of this Resolution shall remain unchanged.

2. All other resolutions, parts of resolutions, or other schedules or fees for any of the permits or services for the Development Department or the Road Department specifically listed in the Schedule that are in direct conflict with the Schedule as amended herein are, to the extent of such conflict, hereby repealed. Fees for any permits or services for the Development Department, Road Department, or any County department or agency, that are not specifically listed in the Schedule as amended herein, shall not be affected by this Resolution and may be adopted, imposed or amended by any lawful means.

3. This Resolution shall take effect August 1, 2017.


