

INVITATION TO BID

NOTICE IS HEREBY GIVEN THAT THE BOARD OF COUNTY COMMISSIONERS OF LEVY COUNTY, FLORIDA hereby calls for and request sealed bids for the following materials to be purchased by said BOARD for and on behalf of LEVY COUNTY, FLORIDA.

Furnishing all KEROSENE, MOTOR OILS, GREASE AND ANTI-FREEZE for the period beginning October 1, 2018 and ending September 30, 2019. The following is an estimate of quantities, but not bind THE BOARD OF COUNTY COMMISSIONERS to any exact quantity.

(1) LUBRICATING OIL: 2500 gallons more or less, Synthetic Blend 15W40, Spec Ck-4 to be delivered to our yard in Bronson, Florida.

(2) GEAR LUBRICANT: Must meet or exceed API Service GL5, SAE Grade 85W140. State bids on a per gallon price delivered to our yard in Bronson, Florida in 55 gallon drums.

(3) CHASSIS LUBRICANT: Delivered to our yard in Bronson, Florida. High quality multi service use, wheel bearings, general chassis, lube, Spec NLGI-2 GC-LB, and fifth wheels. Packaged in 14.5ounce cartridge containers. Bids must be submitted on a per cartridge price.

(4) CHASSIS LUBRICANT: 10 Drums more or less, delivered to our yard in Bronson Florida. NLGI-2, GC-LB, Specs 6 - 120 pound drums.

(5) HYDRAULIC-OIL: Universal Tractor hydraulic UTH Spec, delivered to our yard in Bronson, Florida meets John Deere J20-C specs.

(6) AUTOMATIC TRANSMISSION FLUID: Full Synthetic Multi-vehicle meeting Ford, General Motors, FCA/Chrysler, Mercedes Benz 55 gallon drums delivered to our yard in Bronson, Florida.



I understand that a "public entity crime" as defined in paragraph 287.133(1)(a), Florida Statutes, mean a violation of any state or federal law by a person with respect to and directly related to the transactions of business with any public entity or with an agency or political subdivision of any other state or with the United States including, but not limited to any bid or contract for goods or services to be provided to any public entity or any agency or political subdivision of any other state or of the United States and involving antitrust, fraud, theft, bribery, collusion, racketeering, conspiracy, or material misrepresentation.
3. I understand that "convicted" or "conviction" as defined in Paragraph 287.133(1)(b), Florida Statutes means a finding of guilt or a conviction of a public entity crime, with or without adjudication of guilt, in any federal or state trial court of record relating to charges brought by indictment or information after July 1, 1989, as a result of a Jury verdict, nonjury trial, or entry of a plea of guilty or nolo contendere.
4. I understand that an "affiliate" as defined in paragraph 287.133(1)(a), Florida Statutes, means:
 1. A predecessor or successor of a person convicted of public entity crime; or
 2. An entity under the control of any natural person who is active in the management of the entity and who has been convicted of a public entity crime. The term "affiliate" includes those officers, directors, executives, partners, shareholders, employees, members, and agents who are active in the management of an affiliate. The ownership by one person of shares constituting a controlling interest in another person, or a pooling of equipment or income among persons when not for fair market value under an arm's length agreement, shall be a prima facie case that one person controls another person. A person who knowingly enters into a joint venture with a person who has been convicted of a public entity crime in Florida during the preceding 36 months shall be considered an affiliate.
5. I understand that a "person" as defined in Paragraph 287.133(1)(e), Florida Statutes, means any natural person or entity organized under the laws of any state or of the United States with the legal power to enter into a binding contract and which bids or applies to bid on contracts for the provision of goods or services let by a public entity, or which otherwise transacts or applies to transact business with a public entity. The term "person" includes those officers, executives, partners, shareholders, employees, members, and agents who are active in management of an entity.
